MEMORANDUM FOR GENERAL COUNSEL OF THE DEPARTMENT OF DEFENSE

SUBJECT: Military Justice Review Panel

Pursuant to title 10, U.S. Code, section 946(b)(2), the following individuals have been appointed to the Military Justice Review Panel:

Pursuant to section 946(d), I designate Colonel Lawrence J. Morris, U.S. Army (Ret.), to serve as the Chair of the Military Justice Review Panel.

You are designated as the DoD Sponsor for the Military Justice Review Panel, and delegated the authority to take all necessary steps to effect the appointment of the members identified in the memorandum, including alternates if necessary. Further, you are delegated the authority to approve and issue any documents necessary to constitute the panel and govern its day-to-day operations, and to take those actions necessary to ensure the proper operation of the panel. The authority in this memorandum delegated to you may be re-delegated, in writing, no lower than to a civilian employee of the Department of Defense in the Senior Executive Service. Further re-delegation is not authorized.

You will provide me with periodic updates on the work and progress of the panel, as warranted.
